As the Roading Asset Engineer, I make this submission on behalf of the Waitaki District Council in the area of street lighting. There are just over 2500 streetlights in the Waitaki District of which 2000 are Council owned lights on local roads and 500 are on state highways which we manage under delegation. In 2016, Council began the streetlight upgrade from High Pressure Sodium to LED. The state highways were completed first and those on local roads were completed subsequent to that with all installations complete in 2019.

The move from HPS to LED lights has been significant as the annual power bill for all lights was in the order of \$230,000. With the change to LED streetlights, the power bill has dropped down to \$180,000 and that is with an improved level of service on the state highways. The nett saving for Council has been in the order of \$50,000 per annum which has allowed that money to be targeted to other roading maintenance and safety improvements.

This saving has been made possible merely by the fact that Network Waitaki is run as a Consumer Trust. Other Councils have been less fortunate and have found their line charges increased significantly resulting in a lesser saving or not at all.
