TO BE ELIGIBLE TO STAND FOR ELECTION

A candidate must:

- be aged 18 years or over.
- ✓ reside within the Waitaki Power Trust district.
- ✓ be registered or qualified to be registered on the parliamentary roll.
- ✓ be nominated by a Consumer of Network Waitaki Limited.

A candidate must not:

- be a bankrupt who has not obtained a final order of discharge or whose order of discharge has been suspended for a term not yet expired, or is subject to condition not yet fulfilled.
- be a person who has been convicted of any offence punishable by a term of imprisonment of 2 or more years.
- be a person who has been convicted of any offence punishable by imprisonment for a term of not less than two years and has been sentenced to imprisonment for that offence.
- be a person to whom an order made under section 135 of the Companies Act 1993 applies.
- be a person who is mentally disordered within the meaning of the Mental Health (Compulsory Assessment and Treatment) Act 1992.
- be a person who is not a parliamentary elector for the purposes of the Electoral Act 1993.
- be a person who is holding office as a director of or is employed by Network Waitaki Limited.
- be a person who does not reside in the Network Waitaki Limited District.
